Madera	Capital Facilities and Technology	<p>The Capital Facilities and Technological Needs (CFTN) component worked towards the creation of a facility that is used for the delivery of MHSA services to mental health clients and their families or for administrative offices. Funds used to support an increase in peer-support and consumer-run facilities, development of community-based settings, and the development of a technological infrastructure for the mental health system to facilitate the highest quality and cost-effective services and supports for clients and their families.</p> <p>Technological Needs funding provided opportunities to improve or replacing existing technology systems and/or developing capital facilities (buildings) to meet increased needs of the local mental health system.</p> <p>MCBHS used the Capital Facilities and Technology funding to purchase and renovate our main clinic site. This funding was onetime funding and our county has exhausted this funding stream.</p>
